

IP knowledge hacks: European Patent Office Register – a goldmine of FREE information and tools

This is a brief guide for US Paralegals and Patent Attorneys on how to access FREE information and tools which are available by using the EPO Official Register.

Getting Started

First of all, access the EPO register by clicking the link below or typing 'EPO Register' in your internet search engine.

Once you have accessed the EPO Register

If you have clicked on our hyperlink, you should now be looking at the 'Advanced Search' page on the EPO Register website. It should look like this:


How to use the EPO Register

It is possible under the advanced search tab to search by application or patent number, applicant, inventor, representative, date ranges, International Patent classification, opponent, keywords in the title – a wide range of things. Information concerning the format for search terms is given on the search page.

How to search for granted patents

For granted patents the most useful button is the Federated Register which pulls information from the National patent offices of the member countries such as the UK, Germany etc. and provides a useful single location for relevant data including whether the EPO patent was validated in a particular country, the renewal status, and the registered proprietor. This is useful when conducting due diligence in an assignment transaction. Checking out that the patent is in force and what name it stands in are basic steps readily facilitated by the Federated Register.

There are direct links to the national register entries, which provide definitive information about whether each national patent is in force or not.

What can you do if you need to widen your search?

The EPO register includes a link to Espacenet (highlighted above), which is a wider patent database maintained by the EPO. It includes a list of related family members (listed under 'published as'). In the example case, highlighted below, there is a US equivalent, and the file wrapper for the US case can be viewed via the Global Dossier link near the top of the page after having selected the US case (by clicking the highlighted patent number).

Searching for Japanese and Chinese cases

For Japanese cases, the EPO global dossier will also hold machine translations of office actions, which can save time and money. The same is meant to be true of Chinese cases, but in Barker Brettell's experience the global dossier for Chinese cases is less likely to be up to date.



Free patent watching alerts

It is possible to watch a patent or application by signing up for a free register alert email that alerts you to a change in the register, whether that be the issuing of an office action or the lapsing of a patent due to non-payment of a renewal fee.

It is also possible to submit anonymous observations on-line during prosecution of an application via the Register.

The Register is normally available 24/7, with occasional downtime for maintenance. Attorneys use the EPO Register all of the time – for checking out the portfolio of a competitor company; for watching the prosecution history of patents of interest; in an acquisition to check on the patent portfolio; to check renewal status and ownership, and if any patent is opposed, to search for prior art and family members (via Espacenet). It is also useful to check the current status of the prosecution of attorney's own files.
